NOT ACCEPTING:

party supplies
school supplies (homeschool/educational toys are allowed)



ONLY accepting Chapter Books that are part of a series (i.e. Magic Tree House, American Girl, Harry Potter, Wimpy Kid etc.)

Still **ACCEPTING** all other kid's books- board books, hardcover and paperback, level readers etc.



LIMITED QUANTITIES

Shoes Adult Size 8+ have a limit of **2 tags** per size per gender. Shoes must be for teens, not adults.



LIMITED QUANTITIES

Arts & Crafts must be boxed and are limited to **5 tags**.
Bedding limited to **3 tags**. **See Page 10 for items not accepted.**



Room Decor and Bedding must be marked to reduce.
See items not accepted page.



ACCEPTING Junior Girls & Junior Boys
All Sizes (XS-XL) are acceptable for TEEN brands.
Must be season specific.
Limited to 5 TAGS per gender.
See acceptable brands on the NEXT PAGE.



Item Limits

The following limits have been in place for a few sales. They are outlined below if you need a refresher!



NO LONGER ACCEPTING maternity clothing, DVDs, parenting books, adult books, Mommy Mart



LIMIT 25 Accessories. No used make up/nail polish.
LIMIT 3 Bedding Items (blankets, sheets etc)
LIMIT 5 Arts & Crafts- must be **boxed**, no bags will be allowed.



NO LONGER ACCEPTING Single Onesies
Onesies must be part of an outfit or bundle
i.e. 2-3 onesies together in a bundle or bundled as an outfit with pants similar to how they are purchased in stores



WHEN RESELLING "BRAND NEW WITH TAG" ITEMS:

LIMIT of 5 identical items.
LIMIT 20 of the same items despite color/size.
Bringing more than the 5 item limit, the category limits, or 350 total items will result in a 10% processing fee of gross sales applied (does not apply to gently used items, this is for resalers/wholesalers only).

We will NOT ACCEPT clothing designed and marketed for adult women or adult men. Even if your teen wore it, that does not mean that JBF will automatically accept it for resale. Clothing inspectors will use their discretion to give a final decision. NOTE: Youth Sizes 14/16/18 stay in the youth section and there are no limits on those sizes.

FALL

Item Limits: Please bring your best hanging clothing items which includes up to 5 girls and 5 boys junior sizes.
Max 2 tags for shoe sizes Adult 8+

3/4 Length or Long-sleeved items:
onesies, shirts, dresses

Exceptions for short sleeves: bundled onesies,
heavy winter dresses, athletic tshirts for sizes
6+, winter holidays and sports



Leggings, long pants, jeans
Athletic shorts size 6+,
skirts ONLY in heavy fabric
(corduroy or winter patterns)

13. Is the car seat clean with no visible stains, holes, or tears?	Yes – Continue	No – Clean and repair or Destroy Car Seat

In order to sell a car seat please read, verify and sign the following:

I am the original owner of the car seat that I am selling through Just Between Friends Children's Consignment Sales Event and verify that it has never been in an automobile accident, has not been broken in anyway, has all of its parts, contains the identification label and is 1 year or more from expiration. I verify that the car seat has not been recalled to the best of my knowledge and if so, has been corrected to meet Motor Vehicle Safety standards. I verify that the car seat has all its harness straps, harness clip, seat cover, padding, shield and bolts and that the locking mechanism locks securely.
